

# AMENDMENT NO. 1 TO THE SPONSORSHIP AGREEMENT (6645)

This amendment (this “**Amendment**”) is made as of October 2024 (“**Effective Date**”) and is entered into by and between:

- (1) **GALDERMA NORDIC AB**, a legal entity organised under the laws of Sweden, with registered number 556562-0928, having its principal office at Seminariegatan 21, 752 28 Uppsala, Sweden (“**Galderma**”); and
- (2) **ATOPISK EKSEM FORENING**, a company organised under the laws of Denmark, having its principal office at c/o Lone Grøn Laursen, Hvidovrevej 108, 1. tv. 2650 Hvidovre (“**Event organiser**”),

each a “**Party**” and together the “**Parties**”.

## 1. INTRODUCTION

- 1.1 **Original Agreement.** Galderma and Supplier entered into a Sponsorship agreement dated 19.06.2024 (the “**Agreement**”). The Parties have agreed to amend the Agreement as set out in this Amendment.
- 1.2 **Effective Date of Amendment.** The amendment(s) to the Agreement will be effective as from the date when this Amendment has been signed by both Parties.
- 1.3 **General.** This Amendment shall be deemed as an integral part of the Agreement. Capitalised terms used but not defined in this Amendment have the meaning given to them in the Agreement. If there is a conflict between the terms and conditions of the Agreement and this Amendment, then this Amendment will prevail.

## 2. AMENDMENTS TO THE AGREEMENT

The amendments to the Agreement are as follows:

- 2.1 **Additional sponsoring.** In addition to the previously sponsored amount of 150.000,00 DKK, Galderma agrees to sponsor the project with an additional amount of 20.000,00 DKK.
- 2.2 **Refunding.** Should the allocated amount not be fully utilized in connection with the project, Eksemlforeningen agrees to refund the remaining amount to Galderma.
